Supporting older people to vote in the 2023 local elections

The Electoral Commission

The UK Government has introduced a requirement for voters to show photo ID when voting at a polling station at some elections. This new requirement will apply for the first time in England at the local elections on Thursday 4 May 2023.

Anyone who does not have an accepted form of photo ID will be able to apply for a free voter ID document, known as a Voter Authority Certificate.

We know that older people are more likely to experience barriers in preparing for this change and may need support to access photo ID.

We've created this pack for organisations in England. It's designed to help you raise awareness, and support people you work with to apply for a Voter Authority Certificate, if needed. This pack also includes information on voter registration.

Organisations working directly with voters, including local authorities and charities, can play an important role in supporting voters to ensure they have photo ID ahead of the elections.


Guide for staff and volunteers

- · Other ways to vote


There are two versions of our guide for staff and volunteers. One is designed to be viewed on a computer and has a coloured background. The other is designed to be printed out and has a white background.




